OAKLAND CITY COUNCIL JANUARY 13, 2025 REGULAR SESSION

The Regular Session of the Oakland City Council met in the Oakland City Services Building and was called to order by Mayor Brant Miller (electronically) at 7:03p.m. Pledge of Allegiance was said. Council Members present were Bernard, Moniz, and Reed. Applegate and Perkins absent. City staff present was City Administrator/Clerk Marissa Lockwood. Also present were Jeff Godwin and Matt Mills. Motion by Moniz, second by Bernard to approve the agenda. 3 ayes, motion carried.

Open forum was held. No public comments.

Motion by Moniz to approve the consent agenda including December Clerk Report, January Claims, December Library Report, December Golf Course Report, December Animal Control Report, minutes from December 10th regular session, December fire department minutes, liquor license renewal for Dollar General #6040, Oakland-Riverside Golf Course and Oakland Volunteer Fire Association, temporary event liquor license for Pour Choices on February 15, 2025 at Impact Hill, and Resolution 2025-01-02 "Designating Official Legal Newspaper". Second by Reed. Roll call. 3 ayes, motion carried.

Jeff Godwin with Snyder & Associates gave an update on current projects. Wastewater Improvements – Lagoons project was discussed. Discussion was held concerning contract time and liquidated damages, Council will decide on enforcement of liquidated damages once the project is completed if warranted. Motion by Bernard to approve lagoon project monthly progress monitoring meeting minutes from January 7, 2025. Second by Reed. 3 ayes, motion carried. Motion by Reed, second by Moniz to approve pay application 10 to Hendrickson Transportation in the amount of \$199,500. 3 ayes, motion carried. Wastewater Improvements – Generators project was discussed. Motion by Reed, second by Moniz to approve generators project monthly progress monitoring meeting minutes from January 7, 2025. 3 ayes, motion carried.

Communication issues and complaints received about regular and holiday garbage pickup were discussed with Matt Mills. Motion by Reed to approve amendment to the sanitation agreement with MK Mills Sanitation to allow garbage pickup to begin at 1:00a.m. on Thursdays and to require Mills to give notice to city hall at least four weeks prior to any date change for holiday garbage pickup to allow time for the clerks to get notice out to customers. Holiday pickup may begin at midnight. Second by Moniz. 3 ayes, motion carried.

Motion by Reed to approve Oakland Riverside Golf Course updated By-Laws. Second by Bernard. 3 ayes, motion carried.

Motion by Bernard, second by Moniz to approve Resolution 2025-01-01 "Setting Employee Wages" giving Virgil Smith Jr. a salary increase to \$60,790 for receiving water treatment grade I certification. Roll call. 3 ayes, motion carried.

Lockwood gave the Crew Report in Billings absence. Working on fixing or replacing water meters that have not been reading. Have started the 4-log water treatment process to bring the well behind the city shop online. Billings, Bees and Kiesel will be attending the Iowa Rural Water Conference in Des Moines February 10-12 to obtain necessary CEUs. Will be making repairs to one of the pressure filters at the RO plant. January 20th Billings will no longer be shared with City of Hancock. The water sanitary survey will be on January 21st.

Lockwood gave the Clerk's Report. Set the date for the budget workshop as January 30th at 5:00pm. Working on budget and FEMA project paperwork for June 2024 storm damages. Received notice from Iowa Finance Authority that we qualify as a disadvantaged community to have up to \$700,000 of principal forgiven for the Drinking Water State Revolving Fund loan for the wells project. Gave an update on fund accounting and utility billing software issues, clerks have been researching new software programs.

Miller gave the Mayor's Report. The new ambulance is in service. Motion by Moniz to adjourn. Second by Bernard. 3 ayes, motion carried. Adjournment 8:02p.m.
