OAKLAND CITY COUNCIL OCTOBER 13, 2025 REGULAR SESSION

The Regular Session of the Oakland City Council met in the Oakland City Services Building and was called to order by Mayor Brant Miller at 7:00p.m. Pledge of Allegiance was said. Council Members present were Applegate, Bernard, Ford, Perkins, and Reed. City staff present were City Administrator/Clerk Marissa Lockwood and Public Works Director Josh Billings. Public present were Teegan Williams, Jamie Meek, Tracy Van Zee, Mike Bane and Dr. Stephanie Anderson. Motion by Perkins, second by Bernard to approve the agenda. 5 ayes, motion carried.

Open forum was held. Mike Bane complimented the work on the south water tower and inquired about the possibility of acquiring the piece of property owned by the city behind his house

Motion by Reed to approve the consent agenda including September Clerk Report, October Claims, September Library Report, Golf Course Report, Sheriff's Report, Animal Control Report, minutes from September 8th regular session, fire department minutes from October 5th, pool committee minutes from August 18th, September 7th and October 5th, Resolutions 2025-10-01, 2025-10-02, 2025-10-03 and 2025-10-04 "Placing Lien on Property". Second by Ford. Roll call. 5 ayes, motion carried.

Riverside Schools Superintendent, Dr. Stephanie Anderson was present to provide information on the upcoming Physical Plan and Equipment Levy vote that is on the November 4th ballot.

Pool committee members gave an update on fundraisers and donations they are working on. Bank accounts to receive donations were discussed. Motion by Ford, second by Bernard to approve Resolution 2025-10-05 "Approving Pool Committee Checking Account and signers". Roll call. 5 ayes, motion carried. Motion by Bernard, second by Reed to approve Resolution 2025-10-06 "Approving Community Foundation of Western Iowa fundraising account for pool committee". 501c3 options were discussed. Motion by Ford to approve community building rental fee waiver for Fire & Ice fundraiser with proceeds being donated to the pool improvements project. Second by Perkins. 5 ayes, motion carried.

Public hearing to consider approval of a proposed North Urban Renewal Plan for a proposed Urban Renewal Area in the City of Oakland, State of Iowa was opened at 7:35p.m. No public comments were received. Closed hearing at 7:36p.m. Motion by Bernard to approve Resolution 2025-10-07 "Determining an area of the City to be an economic development area, and that the rehabilitation, conservation, redevelopment, development or a combination thereof, of such area is necessary in the interest of the public health, safety or welfare of the residents of the City; designating such area as appropriate for urban renewal projects; and adopting the North Urban Renewal Plan". Second by Reed. Roll call. 5 ayes, motion carried. First reading of Ordinance 71 - An Ordinance Providing for the Division of Taxes Levied on Taxable property under Section 403.19, Code of Iowa for the North Urban Renewal Plan was held. Motion by Applegate, second by Perkins to approve first reading of ordinance 71. 5 ayes, motion carried. Motion by Reed to approve Ordinance 71, second by Applegate. Roll call. 5 ayes, motion carried.

Motion by Bernard to approve change order 1 for the North Water Main Extension project in the amount of \$8,455.50 to upsize the main from 6" to 8" pipe. Second by Ford. 5 ayes, motion carried. Motion by Ford to approve pay request 3 - final in the amount of \$11,134.20 to Western Iowa Utilities Inc. for the North Water Main Extension. Second by Applegate. 5 ayes, motion carried. Motion by Bernard, second by Ford to approve Resolution 2025-10-08 "Accepting the Work - North Water Main Extension". Roll call. 5 ayes, motion carried.

Motion by Ford to approve pay request 2 for the Wastewater Improvements Project - Sewer Main Replacement in the amount of \$115,258.72 to Western Iowa Utilities Inc. Second by Reed. 5 ayes, motion carried.

Developer Agreement with JP Pierce for the Community Catalyst grant was discussed. Motion by Applegate, second by Perkins to approve Developer Agreement with JP Pierce for the Community Catalyst grant for renovations to 114 N. Main Street. 5 ayes, motion carried.

Not to Exceed \$550,000 GO Capital Loan Note for purchase of 308 Oakland Avenue was discussed. Motion by Reed, second by Applegate to approve Bond Counsel Engagement Agreement with Ahlers & Cooney. 5 ayes, motion carried. Motion by Bernard, second by Perkins to approve Resolution 2025-10-09 "Fixing date for a meeting on the proposition to authorize a Loan Agreement and the issuance of Notes to evidence the obligations of the City thereunder" setting the date for the November 10th regular meeting. Roll call. 5 ayes, motion carried.

Billings gave the Crew Report. Pool and concession stand are winterized, acidizing wells, south water tower painting is completed waiting on parts to finish the piping portion, discussed storm water issue at 408 Dr. Van Zee Rd.

Lockwood gave the Clerk's Report. IMFOA conference October 15-17th. Abstract is being updated for new subdivision in order to complete plat requirements. Special meeting set for November 19th at noon for GO loan issuance. New software is live and things are going well, new online payment system will be live soon and bills received at the beginning of November will have a new look and new account numbers.

Miller gave the Mayor's Report. CMAR proposals for the Water Treatment Plant project were reviewed and scored. Dobbs Subdivision covenants were discussed concerning access to and from the golf course.
